During the Special Meeting of the Council of the Rural Municipality of Blaine Lake #434, which was held in the RM's Municipal Office, at 118 Main Street, on Thursday, March 19, 2020, the following motion was made:

Res#220/20: COUNCIL: WHEREAS the World Health Organization (WHO) assessed COVID-19 as a pandemic on March 11, 2020; and

WHEREAS the Chief Medical Health Officer for the Province of Saskatchewan, directed a number of new orders to control the transmission of COVID-19 on March 17, 2020; and
