Tax Notice Discount Dates & Rates

Tax notices will be issued in the first week of July. Discount dates and rates are as follows: if paid between July 1-31, 2009 - 5% discount; if paid between August 1-31, 2009 - 4% discount; and if paid between September 1-30, 2009 - 2% discount.

Tax Assessment

Sask. Assessment Management Agency staff will be here starting July 6, 2009 to do re-inspections of all properties for tax assessment purposes. Their vehicles will be identified by signs on the doors and assessors will have photo ID. They will be measuring residences, sheds, garages and will also be taking pictures of residences.
