### BYLAW ENFORCEMENT

The Town has hired Commissionaires, a bylaw enforcement company, to assist in enforcing bylaws starting March 1, 2020

Initially, they will be focusing on the following Bylaw violations:

Unattached trailers or semi-trailers parked on town streets or boulevards.

### Bylaw No 8/2013 – Traffic Control

Section 20: Trailer or Semi – Trailer Parked (1) No person shall leave a trailer or semitrailer parked on a highway which is unattached from the vehicle for moving same **and** (3) No person shall park a trailer or semi-trailer on a boulevard or the area set aside for a boulevard

Vehicles Parked in excess of 72 hours.

## Bylaw No 8/2013 – Traffic Control

Section 23: Maximum Parking – 72 Hours Notwithstanding any other provisions in Section 18 and 19, any vehicle parked for an uninterrupted period of time in excess of seventy-two (72) hours on any street or boulevard may be seized, removed and impounded at the expense of the owner thereof.

Unlicensed (no valid plate) vehicles parked on property or land within Town limits

• Bylaw No 2/2006: Nuisance Abatement Junked/unlicensed vehicles – only one unlicensed vehicle (no valid plate) allowed on any land.

Please ensure that you are compliant with the above Bylaws and should you have any questions or concerns with respect to your vehicles or property, please contact the Town Office to discuss.

**Development Permits** are also required for construction of fences, decks, yard screens and small sheds. If any question as to whether a Permit is required, please call the Town Office.



15<sup>th</sup> or 30<sup>th</sup> of the month. Drop into the Town Office to provide your banking information to get set up.


