Town Of Blaine Lake Drinking Water Quality and Compliance Annual Notice to Consumers for 2019

Introduction

Saskatchewan Environment (SE) requires that at least once each year waterworks owners provide notification to consumers of the quality of water produced and supplied as well as information on the performance of the waterworks in submitting samples as required by a Minister's Order or Permit to Operate a waterworks. The following is a summary of the Town of Blaine Lake water quality and sample submission compliance record for the January 1 – December 31, 2019 time period. This report was completed in August 2020. Readers should refer to SE's "Municipal Drinking Water Quality Monitoring Guidelines, November 2002, EPB 202" for more information on minimum sample submission requirements and the meaning of type of sample. Permit requirements for a specific waterworks may require more sampling than outlined in the department's monitoring guidelines. Chemical - Health Category

All waterworks serving less than 5000 persons are required to submit water samples for SE's Chemical Health category once every 2 years. The Chemical Health category includes analysis for arsenic, barium, boron, cadmium, chromium, fluoride, lead, nitrate, selenium and uranium.

The last sample for Chemical Health analysis was submitted in May, 2018. Sample results indicated that no drinking water quality standards were exceeded.

General Chemical

All waterworks serving less than 5000 persons are required to submit water samples for SE's General Chemical category once every two years if a ground water source and once per three months every second year if a surface water or blended surface/groundwater source. The General Chemical category includes analysis for alkalinity, bicarbonate, calcium, carbonate, chloride, conductivity, hardness (as CaCO₃), magnesium, sodium, sulphate and total dissolved solids.

The last sample for General Chemical analysis was required in 2018 and submitted on July 30, 2018. Samples exceeded provincial aesthetic objectives for the General Chemical category for the following parameters:

^{*}Objectives apply to certain characteristics of or substances found in water for human consumptive or hygienic use. The presence of these substances will affect the acceptance of water by consumers and/or interfere with the practice of supplying good quality water. Compliance with drinking water aesthetic objectives is not mandatory as these objectives are in the range where they do not constitute a health hazards. The aesthetic objectives for several parameters (including hardness as CaCO₃, magnesium, sodium and total dissolved solids) consider regional differences in drinking water sources and quality.
